












FROM 2014 TO 2021, FIFTY-NINE EMAIL MESSAGES ALLEGING CHASE DISCRIMINATORY PRACTICES WERE SENT TO THE DOJ'S HOUSING AND CIVIL ENFORCEMENT SECTION, BUT NO CIVIL RIGHTS INVESTIGATION WAS EVER INITIATED BY THIS DOJ FAIRHOUSING AGENCY.
